



State Legal Services Authority (Presently, Executive Chairman, MPSLSA) hoisted the National Flag at the premises of M.P. State Legal Services Authority. The event was graced by the august presence of Hon'ble Judges, High Court of Madhya Pradesh, Jabalpur and other distinguished dignitaries. Following the flag hoisting ceremony, tricycles, hearing aids, and walking sticks were distributed to disabled individuals, symbolizing a commitment to inclusivity and support for differently-abled citizens.









"Green Initiative: MP State Legal Services Authority Launches Mega Plantation Drive to Conserve Environment"

On the occasion World of Environment Day (5th June 2024), a statewide mega plantation drive was inaugurated by Hon'ble Shri Justice Sheel Nagu, the then Acting Chief Justice, High Court of Madhya Pradesh & Executive Chairman, MPSLSA with the objective of conserving environment. This drive set an ambitious goal of planting and conserving 5 lakhs saplings across the state from June 5 to August 15, 2024, as part of the *Panch*-J Abhiyan.



Each district was given task of planting at least 10,000 saplings to achieve the aforesaid target. On World Environment Day, Hon'ble Shri Justice Sheel Nagu urged every family to plant at least five saplings, reinforcing the importance of individual contribution for environmental protection.

Hon'ble Shri Justice Anand Pathak emphasized on significance of not only planting but also conserving saplings. He introduced the "NISARG App" developed by IT Team of High Court to continuously monitor the planted saplings. The campaign concluded on 15th August 2024 with the plantation of a



term conservation and tracking.

MPSLSA's Swift Action Leads to Rehabilitation of Two Differently Abled Girls

In a heartwarming display of empathy and efficiency, the Madhya Pradesh State Legal Services Authority stepped in to ensure timely rehabilitation of two differently abled girls, Lia and Sneha, aged about 15 years and 16 years respectively who were suffering from *Cerebral Palsy with Mental Retardation (C.P. & M.R.)*.

Both girls were residing at "Sneh Niketan Institution" in Jabalpur, having

been admitted there on 9th January 2024 by the order of Child Welfare Committee, Sagar. However, due to their severe physical and mental condition, they required specialized care that was not available at Sneh Niketan. The CWC had ordered their transfer to Ankit Gram Sevadham Ashram, Ujjain, but logistical challenges delayed the move, leaving the girls in a vulnerable state.

Upon learning about the situation from the Principal Magistrate of the Juvenile Justice Board, Jabalpur, MPSLSA as per the directions of Hon'ble Executive Chairman quickly intervened into the



matter. The Authority coordinated with the Department of Social Justice and Disabled Welfare, the Women and Child Development Department, and the District Legal Services Authority, Jabalpur and District Legal Services Authority, Ujjain to expedite the transfer of girls.



With the concerted efforts and involvement of the aforesaid departments, both the girls were safely transferred to Ankit Gram Sevadham Ashram on 12th June 2024 in an airconditioned ambulance ensuring their comfort and well-being during the journey. The Ashram provided necessary medical attention and care for their condition giving both the girls a fresh start.

This compassionate and swift action by MPSLSA exemplifies the Authority's dedication towards protecting the rights of vulnerable individuals, particularly those who are differently

abled and ensuring that they receive the care they need.

MPSLSA conducts Training for Legal Aid Defense Counsels


As per the guidelines issued by National Legal Services Authority, New Delhi, training program for Chief Legal Aid Defense Counsel and Deputy Legal Aid Defense Counsels was organized from 1st July, 2024 to 3rd July, 2024 and for Assistant Legal Aid Defense Counsels from 8th July, 2024 to 10th July, 2024 at M.P. State Judicial Academy, Jabalpur.



On 8th July 2024, Hon'ble Shri Justice Sanjeev Sachdeva, the then Acting Chief Justice, High Court of

Madhya Pradesh (Presently Executive Chairman, MPSLSA) inaugurated a three-day Capacity Building Training Programme for Assistant Legal Aid Defense Counsels (LADCs) working across the state. The training was organized by Madhya Pradesh State Legal Services Authority. In the said training, 66 female Assistant Legal Aid Defense Counsels participated, highlighting the active involvement of women in ensuring access to justice for marginalized sections of the society.

In his address, Hon'ble Shri Justice Sachdeva emphasized the critical importance of ensuring that every accused person has access to a quality defense lawyer. He noted that providing legal aid to the poor and marginalized people has always been a primary goal of the Legal Services Authority. The training aimed to equip the Legal Aid Defense Counsels with essential skills and well-versed with newly implemented Criminal Laws enhancing their ability to represent the underprivileged.





Counsel System (LADCS), launched nationwide under NALSA's Legal Aid Defense Counsel Scheme, 2022, has created a dedicated cadre of Advocates specifically tasked with defending the accused persons. The participation of 66 female counsels in this program marks a significant

milestone in the evolving role of women in the legal profession, demonstrating their dedication to ensuring access to justice for all members of the society, particularly the marginalized ones.

Empowering Futures: "Samvad" Consultation Addresses Needs of Children with Disabilities

On 3rd & 4th August, 2024, the Madhya Pradesh State Judicial Academy, Jabalpur hosted an impactful State Level Consultation "*Samvad*" on the Protection of Children with Disabilities which was inaugurated by Hon'ble Shri Justice Sanjeev Sachdeva, the then Acting Chief Justice, High



Court of Madhya Pradesh (Presently Executive Chairman, MPSLSA). This twoday event brought together key stakeholders to discuss critical issues affecting children with disabilities.

Jointly organized by the Juvenile Justice Committee, M.P. State Legal Services Authority, Government of Madhya Pradesh, and UNICEF Bhopal, the consultation aimed to develop comprehensive understanding of the challenges these children face, particularly those in conflict with the law.

In his keynote address, Hon'ble Shri Justice Sanjeev Sachdeva emphasized on need to reflect on and enhance support systems for children with disabilities. He accentuated the fact that proper nurturing, including medical support, special educational training, and appropriate resources, is essential for enabling these children to thrive. His Lordship further stressed the importance of adhering to the Rights of Persons with Disabilities Act, 2016, ensuring that every child's dignity is upheld throughout their journey.

The gathering, which included esteemed dignitaries such as Hon'ble Shri Justice Sushrut Arvind Dharmadhikari and Hon'ble Shri Justice Anand Pathak, Judges, High Court of Madhya Pradesh highlighted the collaborative spirit required to drive meaningful change. "Samvad" serves as a vital step towards



fostering an inclusive environment where every child can reach their full potential.

This consultation not only illuminated the pressing needs of children with disabilities but also reinforced the commitment of the judiciary and related organizations to champion their rights and well-being.

Advocates Trained on Child Rights: A Two-Day Programme at MPSLSA

On 21st& 22nd September, 2024, the Madhya Pradesh State Legal Services Authority hosted a significant two-day training programme focusing on Child Rights, organized in collaboration with UNICEF and HAQ: Centre for Child Rights. This initiative was inaugurated by Hon'ble Shri Justice Vivek Rusia, Judge, High Court of Madhya Pradesh, in the auditorium of MPSLSA.

In his inaugural address, Hon'ble Shri Justice Rusia laid emphasis on the

sensitive nature of cases involving children. He urged Advocates to consider the broader context of each case, stressing the importance of understanding background, reasons, and circumstances that lead to a child's involvement in legal proceedings. His Lordship called for a compassionate approach, encouraging Advocates to view children not merely as clients but as their own.



He highlighted the necessity of incorporating counseling into legal processes when dealing with children, reinforcing that emotional support is an essential part of advocating for their rights. This training programme aimed to equip legal professionals with the knowledge and skills required to navigate the complexities of child-related cases effectively and empathetically.

Under the guidance of Hon'ble Shri Justice Sanjeev Sachdeva, the then Acting Chief Justice, High Court of Madhya Pradesh (Presently Executive Chairman, MPSLSA), this event marked a vital step in fostering a more sensitive



and informed legal framework for the protection of child rights in the state. By focusing on these critical issues, the training program aimed to empower Advocates to make a meaningful difference in the lives of vulnerable children.

Empowering Paralegal Volunteers: Training on Child Rights at MPSLSA

On September 23, 2024, Hon'ble Shri Justice Sanjeev Sachdeva, the then



Acting Chief Justice, High Court of Madhya Pradesh (Presently Executive Chairman, MPSLSA), inaugurated a two-day training programme for Para Legal Volunteers focusing on Child Rights. This initiative was organized by the Madhya Pradesh State Legal Services Authority (MPSLSA) in collaboration with UNICEF and HAQ: Centre for Child Rights which took place at the premises of MPSLSA in the esteemed presence of Hon'ble Shri Justice

Vivek Agarwal, Judge, High Court of Madhya Pradesh.

During the inauguration, His Lordship highlighted the critical role of stakeholders in protecting children from harmful narratives that can distort their perception of reality. He pointed out that repeated falsehoods can become accepted as truth, making it imperative for everyone to distinguish between truth and deception. In this context, he emphasized the significant impact that Para Legal Volunteers can help to uncover and present the realities faced by children.

Hon'ble Shri Justice Sanjeev Sachdeva further remarked on the delicate and fragile nature of a child's mind, stressing that a child's development and overall well-being are profoundly influenced by how they are nurtured and guided. He urged participants to approach their work with sensitivity, recognizing the profound responsibility they carry in shaping the lives of children.

This training programme aimed to equip Para Legal Volunteers with the necessary skills and knowledge to advocate effectively for child rights, ensuring that the voice of vulnerable children is heard and their rights be protected. By fostering a deeper understanding of the challenges faced by children, this initiative serves as a vital step toward building a more just and supportive environment for all children in Madhya Pradesh.



Symposium for Intellectual Property Rights for Advocates

On 16 October, 2024 Hon'ble Shri Justice Suresh Kumar Kait, Chief

Justice, High Court of Madhya Pradesh & Patron-in-Chief, MPSLSA inaugurated a symposium on Intellectual Property Rights (IPR) for Panel Lawyers and Legal Aid Defense Counsels in the august presence of Hon'ble Shri Justice Sanjeev Sachdeva, Administrative Judge, High Court of M.P. & Executive Chairman, M.P. State Legal Services Authority and other Hon'ble Judges of High Court of Madhya Pradesh. Symposium was jointly organized by M.P. State Judicial Academy & M.P. State Legal Services Authority for the purpose of capacity building of Advocates so as to develop in-depth understanding of issues related to intellectual property.



On the above occasion, Hon'ble Chief Justice addressed the gathering and said that today Intellectual property is not just a legal concept, but a driving force behind economic growth, cultural development, and the protection of creativity. The role of intellectual property becomes increasingly crucial in nurturing and protecting talent, it is vital that we, as a legal community, are



well-versed in the ever-evolving field of intellectual property law.

Hon'ble Chief Justice further added that with the advent of new technologies like Artificial Intelligence, new challenges are emerging. Our courts, including the commercial courts, are likely to face novel and complex issues that we have not encountered before. To address these effectively, both judges and advocates must equip themselves with a deep understanding of these new dimensions and the symposium is a step in that direction.

On the occassion Hon'ble Shri Justice Sanjeev Sachdeva pointed out the need to make individuals aware of their rights related with intellectual property so that they could recognize the violations and seek the remedies available to them. His lordship also asserted that knowledge about intellectual property laws must reach to everyone especially those who are related to it.

The role of cross-examination is very crucial in deciding the dispute and protecting truth, therefore, it is vital that we, as a legal community, must be well-versed in the techniques related with cross-examination.

Subject Expert for the aforesaid Symposium on "The Art of Cross-Examination" Shri Rajeev Virmani, Senior Advocate, Supreme Court of India, New Delhi highlighted and explained the various important techniques through which the process of cross-examination can be learned and developed.





Celebrating Constitution Day

On the occasion of Constitution Day dated 26th November 2024, Hon'ble Justice Shri Suresh Kumar Kait, Chief Justice High Court of Madhya Pradesh and Patron-in-Chief, Madhya Pradesh State Legal Services Authority, Jabalpur, lighted *Nyaya Jyoti* in the premises of MPSLSA in the august presence of Hon'ble Judges of High Court of Madhya Pradesh . In order to spread awareness about the harmful effects of drug addiction Hon'ble Chief Justice also flagged off a public awareness vehicle rally from the office of

On the occasion Hon'ble Chief Justice addressed the gathering and emphasized upon the significance of Constitution. His Lordship also said that Social justice is one of the preambular goal enshrined in the constitution of India and this goal can be achieved only when access to justice is ensured to the person living at the lowest level of the society.

Hon'ble Chief Justice also flagged off a public awareness vehicle rally with the objective of making the general public, especially the youth, aware of the ill effects of drugs. As it is being observed these days that the trend of drug abuse is increasing among the youths of the country, which not only has an adverse effect on their health but also has negative impact on the economic and social development of the country. The said vehicle rally reached major public places and intersections of the city and the general public was made aware of the ill effects of drugs through banners, posters, promotional material etc. related to de-addiction.





Chief Justice's Gesture Brings Mobility to a Disabled Girl



Promoting Rights Awareness: NALSA Guidelines Implemented in Madhya Pradesh

In alignment with the National Legal Services Authority (NALSA) guidelines on "Early Access to Justice at Pre-Arrest, Arrest, and Remand Stage," significant measures were taken to enhance awareness of suspects' rights across State of Madhya Pradesh. Hoardings displaying these rights were installed at various police stations state-wide, and informative leaflets were distributed to the public.

Additionally, duty rosters for Panel Lawyers and Para Legal Volunteers (PLVs) were established for remand courts, with necessary instructions issued to Police Headquarters (PHQ) and Station House Officers (SHOs) at the relevant police stations. These efforts aim to ensure that individuals are informed of their rights, promoting access to justice at critical stages of the legal process.

LADCS Scheme: A Significant achievement

> Capacity Building Training Program for Legal Aid Defense Counsels.

As per the directions of National Legal Services Authority, New Delhi, a 03 days Capacity Building Programme for Chief Legal Aid Defense Counsels and Deputy Legal Aid Defense Counsels had also been organized in collaboration with M.P. State Judicial Academy from 01.07.2024 to 03.07.2024 and another 03 days Capacity Building Programme for Assistant Legal Aid Defense Counsels organized from 08.07.2024 to 10.07.2024.

> Effective implementation of Legal Aid Defense Counsel System (LADCS) in all districts of the State.

In order to strengthen the mode of delivery of legal services in criminal matters and making it more professional, NALSA introduced 'Legal Aid Defense Counsel System' for providing legal aid in criminal matters on the lines of public defender system and as per the mandate of NALSA, MPSLSA has adopted and implemented the aforesaid scheme in letter & spirit.

From 20.10.2023, Legal Aid Defense Counsel Scheme has been successfully made operational in all the 50 judicial districts of Madhya Pradesh. Under the said scheme, the Legal Aid is being provided to all the entitled persons in efficacious and effective manner in all the criminal matters at district headquarters. In Legal Aid Defense Counsel System, the defense counsels are appointed on full-time basis and are not permitted to continue private practice.

After the implementation of LADCS, erstwhile system of Panel Lawyers is operative only for providing legal aid to the complainants/victims in criminal matters, legal aid in civil & revenue matters/JJBs/CWCs/all tribunals having civil jurisdiction. These training programs reflect the commitment of Madhya Pradesh State Legal Services Authority to foster a culture of mediation among legal practitioners, ultimately contributing to a more efficient justice delivery system. Participants are encouraged to apply the skills acquired in their practice, helping to resolve disputes amicably and effectively.



Empowering Future: Summer Internship Program

On June 11, 2024, the M.P. State Legal Services Authority launched the third batch of its *21-day summer internship program* designed for law students from colleges and universities across State of Madhya Pradesh as well as other states. This initiative aims to provide aspiring legal professionals with practical experience and insights into the working of legal system.

Throughout the internship, participants engaged in various activities,

including attending court sessions. participating in legal research, and assisting in the preparation of legal documents. The program also included workshops and seminars led by experienced legal practitioners and Judges, enhancing students' understanding of crucial legal concepts and practices.





Quick resolution of calls received under toll free NALSA Helpline no. 15100



NALSA's Toll free Helpline no. 15100, a revolutionary initiative of the National Legal Services Authority, New Delhi aims at providing access to justice for all in India. It helps in providing legal aid and guidance for all, especially marginalized communities who may face barriers in accessing legal services.

Under the guidance of Hon'ble Shri Justice Sanjeev Sachdeva, Executive Chairman, Madhya Pradesh State Legal Services Authority, all DLSAs were directed to ensure that no incoming calls on 15100 should remain pending and must be dealt in a proper manner.

In this regard, it is noteworthy that from June 2024 to December, 2024, a total of 13692 incoming calls have been received on Toll Free No. 15100. It is also pertinent to mention that a total 13692 incoming calls including a total 5153 Emergency calls were addressed effectively and Legal aid was provided to the callers who were found entitled for the same.

Victim Compensation Scheme

Victim Compensation Scheme plays a pivotal role in supporting victims of crime and ensuring their access to justice and rehabilitation. In a recent update, a total of 471 cases were disposed of under the scheme resulting in a substantial award amount of ₹10,27,07,300.

This initiative shows commitment towards public welfare by providing financial assistance to victims, helping them in recovering from the impact of crimes, and facilitating their reintegration into the society. By addressing the needs of victims, the Scheme fosters a sense of justice and support within the community thereby reinforcing state's dedication to protect the rights of individuals affected by criminal activities.

A Lifeline for Alma: MPSLSA Triumphs in Securing Education Documents

Education is crucial for a child's personal and professional development, well-being, and overall quality of life. Therefore, it becomes a collective responsibility of every individual to ensure that every child gets all the opportunities which are helpful in completing his or her educational journey.

Below is a real life story of a 13-year-old orphan, Ms. Alma Raj, residing in Kerala. She wanted to complete her education but non-availability of some documents created impediments in completing her educational journey.

In a heartwarming turn of events, following directives from the Hon'ble Kerala High Court, an *amicus curiae* stepped in as advocate for Alma, showcasing the power of compassion and legal support. Since she was a native of Anuppur, Madhya Pradesh and upon learning of Alma's situation MPSLSA rallied to assist Ms. Alma Raj and issued directions to the District Legal Services Authority, Anuppur to swiftly take action and coordinate with the Board of Secondary Education, Bhopal to ensure the availability of Migration Certificate. Certificate was issued by Board of Secondary Education, collected by DLSA, Bhopal and sent to DLSA, Anuppur, demonstrating a seamless collaboration and coordination across legal jurisdictions.

"Training Para-legal Volunteers as support persons under the POCSO Rules"

Under the guidance of M.P. State Legal Services Authority, District Legal Services Authorities across the State of Madhya Pradesh organized training programs to equip Para-Legal Volunteers as support persons under the POCSO Act and Rules. These programs aimed to provide essential skills and knowledge, enabling volunteers to assist victims and their families in navigating the legal landscape. Participants learned about child rights and best practices for providing emotional and legal support. This initiative creates a

network of compassionate Advocates, enhancing the legal system's capacity to protect vulnerable children and fostering a community-driven approach to safeguard their rights. Together, we can build a safer environment for every child.

Additionally, E-service facilities were tested under the E-court project, exploring video conferencing capabilities and ensuring smooth operation of local schools and community health centers. This initiative reinforced the commitment to making legal resources accessible and responsive as per the needs of the community.

DLSA DAMOH

On July 29, 2024, a Special Legal Aid and Awareness camp was held in Tindauni village. The District Judge/Secretary emphasized the importance of citizens having access to essential government documents such as Aadhar Cards, Ayushman Cards, Birth Certificates, and Caste Certificates to take benefit from public welfare schemes. The camp aimed to address the issue of document deprivation by coordinating with various government departments, including Panchayat and Rural Development, Women and Child Development, Labour, and Health. As a result, a total of 137 documents were distributed,

including 57 birth certificates, 14 Ayushman cards, 14 new ration cards, 12 food grain slips, 23 Aadhar cards, and 17 Sambal cards. Additionally, 157 new applications were received for issuance of Aadhar cards, birth certificates, and other essential documents, ensuring that eligible citizens could access government benefits.


