- Online regular classes will be conducted from Monday to Saturday of every week between 05:30 pm to 07:30 pm. The date of commencement of the aforesaid programme will be shared on the website of MPSTLSA.
- No fee shall be charged from any candidate.
- The interested candidates fulfilling the eligibility criteria for appearing in the Civil Judge Junior Division (Entry Level) Recruitment Exam-2022, may submit his/her application through the google form link provided at the end of this document.
- The submitted forms shall be scrutinized in respect of whether the applicant is eligible to appear in the Civil Judge Junior Division (Entry Level) Recruitment which is conducted by competent authority.
- The details of sessions to be held viz. Subject, Link, Timings & Dates shall be communicated on the website of MPSTLSA. Applicants are advised to visit the website regularly for programme related updates.
- The programme will be hosted via Cisco Webex or any other suitable online platform on the basis of number of candidate participating in the programme.
- Preference will be given to the candidates belonging to SC/ST, Minorities, Women, EWS etc.
